Proposed timeframes in the draft environment protection legislation

Introduction

The Northern Territory is reviewing and reforming the current environmental regulatory system. Reforms are critical to achieving a robust regulatory system that the community will trust while encouraging industry investment and economic growth, and delivering improved environmental outcomes.

As part of these reforms, the Territory Government has made commitments to streamline processes, improve accountability and improve timeliness.

The draft environment protection legislation introduces timeframes for the majority of decisions made under the legislation. This paper provides an overview of the proposed timeframes in the new environmental impact assessment and approval system.
